

# Term of Use

Please read these terms of use (the "Terms") carefully before using Temple Bliss website and/or mobile application.

These Terms create a binding agreement ("Agreement") between you ("End User" or "You") and ECG SOLUTIONS LLC ("ECG," "Us," "We," or "Our").
